Terms & Conditions ASVA Cargo Bike

A few conditions apply to renting the ASVA Cargo bike. Here you can read these conditions and why they apply to the ASVA cargo bike.

Student

To be able to rent the ASVA Cargo bike, you have to be a member of the ASVA Student Union. You must be a student at an educational institution in Amsterdam or the surrounding area to become a member. The cargo bike can therefore only be rented by students in Amsterdam and the surrounding area who are members of ASVA. Partner organizations can also borrow the cargo bike.

Reservation and pick-up

To rent the cargo bike, make a reservation for the desired rental period by sending an email to studentenbalie@asva.nl or call us on 020 - 525 29 26.

State the following in this email:

- Desired rental period of the cargo bike
- Desired pick-up and drop-off time during the opening hours of our student desk
- Your name

If the cargo bike is available for this period, you will receive a confirmation of your reservation. The student desk will then let you know what time the cargo bike is available.

Rental and prices

In addition to the rent, we also ask for a € 150 deposit which must be paid in cash at the student desk.

The rent is:

- €10 for a day
- €15 for a weekend

The new day rent commences daily at 15:00h.

If you return the cargo bike later than the agreed time, €5 will be deducted from the deposit. If you have not returned the cargo bike at 15:00, a new day's rent will commence and you will therefore pay another € 10 extra. This also applies to partner organizations. We apply these rules so that as many students as possible can use the cargo bike!

Liability tenant

- Both the tenant and the lessor ensure that the cargo bike is rented out in good condition, without defects. Any damage is described on the lease.
- The tenant is liable for all damage that has occurred during the rental period.
- The tenant is liable for the loss of the cargo bike.
- Upon seizure of the cargo bike, the tenant remains obliged to fulfill the obligations of the
 rental agreement, including the payment of the rental price until the time that the cargo bike
 is back in the possession of the lessor. The tenant is responsible for all possible costs that
 seizure may entail.

In deviation from the agreed deposit, a high deductible (eigen risico) of

- A maximum of €1250 for the tenant who is both consumer and a non-consumer

Cancellation or extension

The rental can be canceled free of charge up to a week before the start of the agreed rental period. Up to 24 hours before the start of the rental period, the ASVA Student Union will charge the rent of the cargo bike.

The tenant is obliged to return the cargo bike in time as agreed, extension is possible if this has been agreed in time.
